**What is Title I?**

Kingsland Elementary is identified as a Title I school as part of the Elementary and Secondary Education Act of 1965 (ESEA). Title I is designed to support State and local school reform efforts tied to challenging State academic standards in order to reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement. All Title I schools must jointly develop with all parents a written parental involvement policy.

**School Plan for Shared Student Achievement**

**What is it?** This is a plan that describes how Kingsland Elementary will provide opportunities to improve parent engagement to support student learning. Kingsland Elementary values the contributions and involvement of parents in order to establish an equal partnership for the common goal of improving student achievement. This plan describes the different ways that Kingsland Elementary will support parent engagement and how parents can help plan and participate in activities and events to promote student learning at school and at home.

**How is it developed?** Kingsland Elementary School welcomes parent input and comments at any time regarding the plan. All parent feedback will be used to revise the plan for next year. The plan is posted on our school website for parents to view and provide feedback throughout the year. We also distribute an annual survey online and by student to ask parents for their suggestions on the plan and the use of funds for parent involvement.

**What feedback indicated?** The yearly survey showed that parents thought that e-mail (86% surveyed) automated phone calls (75%), and newsletters/flyers (74%) were the best ways that the school could communicate with them. Additionally, parents want after school/evening workshops on how they can help with homework and also help their child improve their reading and math skills. Additionally, parents would like information on how to prepare their child for tests and also effective parenting skills. Activities will be planned to address these needs during the 2016-17 school year.

**Who is it for?** All students and their families are encouraged and invited to fully participate in the opportunities described in this plan. Kingsland Elementary will provide full opportunity for the participation of all parents, including those with limited English, parents of students with disabilities, parents of homeless and migratory children, as well as guardians of neglected or delinquent children.

**Where is it available?** Once adopted, the plan is posted on-line on the school website, in the parent resource center, and in the front office.

### **2016-2017 District Goals**

*-To increase Math GMAS (Georgia Milestones Assessment System) performance at the elementary (53% to 56%), middle (43% to 46%), and high school (56.5% to 59.5%) levels.*

*-To increase ELA GMAS performance at the elementary (45% to 48%), middle (42% to 45%), and high school (50% to 53%) levels.*

### **2016-17 School Goals**

*To increase the percentage of students performing at the proficient and distinguished level on the 2017 math EOG from 57% to 60%.*

*To increase the percentage of students performing at the proficient and distinguished level on the 2017 ELA EOG from 44% to 47%.*
